CAMPAIGN PHOTOGRAPHY.

I take pictures of supporters with signs, supporters with candidates and of Democrats campaigning at six hundred seventy-three events since 2009. In the beginning, I simply attended events, handed supporters a sign, took their picture and urged them to share the picture on their Facebook page. In the past two years, I wait to be asked, rather than just show up and bother the supporters. Last year was 140 events; this year to date is 65 events. You have limited the resume to two pages, so I will simply say that my view count on Flickr is 4,074,769. Facebook doesn't show me how many people look at the pictures and they don't total up the "likes," but my albums usually get more than a couple of hundred "likes."
