Has received numerous awards for community service, including Maryland Citizen Award, The League of Korean Americans of Maryland and Maryland's Top 100 Women.

**Jill Reid Cummins** Extensive litigation and trial experience in State and Federal Courts in Maryland and DC. Managing Attorney for Allstate Insurance Company's Capital Region for 13 years. Montgomery County resident for more than 48 years. Graduate of University of Virginia, American University and Washington College of Law. Active in the Street Law program for local high school students throughout the Metropolitan area and assists with voter registration and training.

**Debra L. Dwyer** Appointed to Circuit Court bench in 2016. Served as Deputy Chief at the U.S. Department of Justice's Organized Crime and Gang Section and Montgomery County State's Attorney's Office as Assistant State's Attorney.
